Dear Mr McLear,

I am writing to you regarding the above Penalty Charge Notice.

We have not ignored any correspondence that you have sent us but there is a clear and defined system for appealing that needs to be followed. This is explained on the Penalty Charge Notice, your letter of rejection and the Notice to Owner.

You appealed this PCN back in May but your appeal was unsuccessful. You then tried to appeal again before an Notice to Owner was issued to you (you must wait until this is issued otherwise you will be sent a 2nd appeal before NTO letter). A 2nd appeal before NTO letter has been produced twice and sent out to you on the 11th and 17th May 2010.

We then sent you a Notice to Owner on the 18th June 2010, this would have allowed you to make a formal representation against the PCN, you chose not to do this and since then we have sent you a Charge Certificate on the 19th July 2010. You now have no right of appeal and the PCN must be paid. The amount outstanding currently stands at £75.00. You can make payment by calling 01274 434300.
